From the East





My Dear Brother,

With our youngest Master Masons finishing their Master Mason Degree we look at the use of the trowel. Operative masons use trowels to spread the cement or mortar which unites the bricks or stones of a building into a common mass. The trowel is the instrument which is used to distribute the bonding material in the proper proportions between the separate building units of a structure.

Speculative Masons are taught to regard the trowel as the principal tool of a Master Workman. Its symbolical use is to spread the cement of brotherly love and affection; and it is no mere coincidence that the principal working tool of a Master Mason is linked to the central purpose which Freemasonry has always proclaimed.

Obviously, Freemasons should be concerned with a figurative trowel, a symbol, which represents a certain kind of behavior, a mode of conduct, which every Master Mason is charged to practice. In the transfer of ideas involved in such a metaphor, it is clear that the

individual Brother is being exhorted to become a trowel, which distributes in proper proportion the bonding materials of brotherly love and affection. He is to be a force which helps to unite the divided human units of society into a harmonious structure of civilization.

The founders of Speculative Freemasonry bequeathed to their followers a book of moral charges. The "Ancient Constitutions" mean little if they are not interpreted as such, with the underlying idea being the ancient virtue of humanitas, the ability to express humane feelings, - kindness, gentleness, helpfulness, - by means of a benevolently disciplined character which has achieved good breeding and culture, and which displays them through brotherly love.

The principal object of Freemasonry has always been to perfect the individual and to guide mankind toward a better, more harmonious development. The individual Mason is a Builder on the Temple of Human Brotherhood; he is both the trowel and the cement which combine the units of society into a cohesive whole. The brotherly love he extends to others is the trowel; the appreciation and affection he arouses are the cement which helps to bind men closer to each other.

Congratulations to our newly raised Brother Master Masons!



Medford Lodge - Bi-Laws Change



Proposed Changes to Medford Lodge #178 Bay Laws

Order of Business amend to read:

Memoriam (Moment of Silence for recently deceased brethren if appropriate) MM degree Examination (if appropriate) Reading from Constitution Regulations and By Laws Reading of Minutes from previous Communication Treasurer's Report Report of Committees of Investigation Ballot for Candidates Reading of Petitions for Membership Committee Reports Reading of Communications Old Business New Business Agenda for Evening (Presentation for Masonic light or edification of lodge, Gold Token night, Official visits, Initiation of candidates as appropriate)

Article II Officers, Section 2.Amend to read:

The appointed officers shall consist of a Chaplin, Senior and Junior Deacons, Senior and Junior Masters of Ceremonies, Senior and Junior Stewards, Marshall, <u>Historian</u>, Organist and Tyler who shall be appointed by the Worshipful Master on the night of installation

Article II Lodge Trustees. Replace entire section to read:

The Lodge Trustees shall consist of three members. One Elected for one year, one for two years and one for three years, thereafter, at each annual election, one Lodge Trustee shall be elected for a term of three years. Lodge Trustees shall be elected at the stated December meeting. Trustees must be a member of the Lodge for a five year period prior start of their three year term.

Lodge Trustees may also hold an appointed office in the lodge.

The duties of the Trustees shall be to receive, hold, care for and invest, under direction of the Lodge, all funds not required for current operations. This shall include the authority to open, maintain and manage investments, accounts etc. to meet the requests of the Lodge.

They shall promptly report to the Lodge in writing each investment made by them. They shall keep themselves informed as to the conditions relating to any of the securities or investments of Lodge funds and shall promptly report to the Lodge in writing any matter effecting such investments or securities. They shall keep all securities of the lodge on record in the name of Medford Lodge No. 178 F. & A.M., at financial institution designated by the Lodge.

They shall render a quarterly report at the stated meeting in month following the close of a calendar quarter. For any quarter that is reported while the Lodge is on hiatus for the summer, a report will be given to the Lodge at the first stated meeting of return. Each January, they will give a full year reporting of all investments and property held by them with proposals for changes there to including holdings, balance, gain or loss and change in investment strategy. In case of matters of urgency concerning lodge investment they will promptly report to the Master, Wardens and Treasurer to address at the next regular communication or call an emergent communication as appropriate.

Lodge funds shall be invested only as approved by the Lodge in investments that are lawful and are not associated with current or past members. Investments in debentures shall be invested be a balanced combination of Savings Funds, Certificates of Deposits, bonds issued by the US Federal Government or its Agencies, Municipal bonds, triple A rated commercial paper or triple A rated dividend paying stock or mutual funds that invest in the same or Real Property.

Medford Lodge - Bi-Laws Change

Vacancies in the office of Lodge Trustees created by death, resignation or removal from the jurisdiction of an incumbent, shall be filled ad interim by an appointment by the Worshipful Master until the next annual communication, when an election shall be held for the unexpired term so vacated.

Article III Committees add the following

- Section 5. A Charity Committee of two or more who shall organize and run fundraisers for the lodge Charity Fund. They will also be the point of contact for charities and recommend to the lodge donations to charities and coordinated with the treasurer for disbursement of donations by order of the Worshipful Master with the consent of the lodge
- Section 6. A Sickness and Distress committee of two who will inform the lodge of any brethren who are ill, infirmed, hospitalized, or experiencing personal hardships. Contact brethren and families for well wishes, inquiring and offering lodge assistance, and coordinate hospital, nursing home visits. Also to coordinate Masonic Home visits and wheel chair pushes.
- Section 7. A Ritual Committee of Past Masters who assist the Worshipful Master in rehearsals and improving the proficiency of the lodge in Masonic ritual
- Section 8. As Hospitality Committee who will assist the Stewards as necessary in coordinating meals for regular communications and degrees and assist in District Hospitality Rooms during Grand lodge

Section 9. A By-Laws committee of two who will review and recommend to the lodge any changes deemed appropriate Section 10. The Worshipful Master may appoint other temporary committees as necessary

Article VI Fees and Dues

Section 1. Add final sentence

The initiation fee will be considered payment of dues for the Masonic Year the candidate was raised to the sublime degree of Master Mason

Section 2 Amend to read

The annual dues shall be \$65.00 plus the Grand Lodge assessment payable in advance; provided however, that upon granting a demit, the Lodge shall remit such portion of the dues as shall be unearned. Annual dues may be adjusted based projection of the lodge finances. In such cases the annual dues adjustment for the following year must be voted and approved by the lodge. Notice of the change and justification must be posted in the trestle board a month prior to voting and the vote must be completed prior to the annual communication in December.

Section 2. Add final sentence

Members in good standing of any age who are disabled or suffering hardship may appeal for a waiver from annual dues. The lodge will vote on the waiver and if granted will be charged \$1.00 plus the Grand Lodge assessment will be required.

New Article VIII Stipend

The Secretary and Treasurer are authorized to receive a stipend in recognition of their need for supplies, the time necessary to perform their duties, the time spent coordinating and generating monthly and annual reports to Grand Lodge, the Grand Secretary, and performing other business of the lodge. The lodge will determine the stipend amount annually.

Existing Article VIII, IX and X will be renumbered to articles IX, X and XI respectively


