Greetings Brethren,

I was recently lent a collection of Masonic books by a generous brother among which were the Introduction to Freemasonry books by Carl H. Claudy volumes one to three, Entered Apprentice, Fellow Craft, and Master Mason degrees.

These are excellent sources of Masonic light about our degree ritual. Since we just finished a wonderful Entered Apprentice degree in the Lodge, I thought it would be interesting to read Volume One and review one small section of it here.

I was most taken with his explanation of the first, and lifelong, outward symbol of a Mason, the Lambskin Apron. We present it to our new brother to keep as a badge of his new status as a Masonic brother for the rest of his life. It both symbolizes that he is from then on, welcomed and accepted as one of our special fraternity. But I believe it also symbolizes that he accepts the work ahead of him, and the duties and responsibilities of maintaining and building our speculative Temple through continued work and study of further light in Masonry as he progresses through the degrees and throughout life.

The Mason apron is indeed more ancient than the Order of the Garter which King Edward III awarded to himself in 1349. (He also awarded it to 25 buddies presumably because it's no fun to have a club with no members.) Aprons were a symbol of position and power among Hebrew, Egyptian, Chinese, Incas and Aztecs pre-dating the Old Testament. Throughout the Old Testament the Lamb has been a symbol of innocence, purity and sacrifice.

Thus in donning our aprons we affirm our commitment to the purity of our Lodge and our pledge of sacrifice to all humanity. Thus may we always wear ours with pleasure to ourselves and with honor to the Fraternity.







My Brothers,

When I was running to serve as your Junior Grand Warden in 2015, I promised you that if elected, I would strive to bring transparency to the brethren concerning the finances of our Grand Lodge. Almost two years ago, I proposed legislation that was adopted, mandating the publishing of the audited Grand Lodge finances. After numerous months, once all the paperwork was completed, the final report of the independent auditor has been received and the findings are startling. I held a meeting on Friday, March 8, 2019 with the independent auditor, the elected line, Grand Lodge office administrator, Acting Grand Secretary, President of the Grand Lodge Board of Trustees and the audit committee. The purpose was to review the independent auditors report.

It goes without question that for some time, there has been questions related to the finances of the Grand Lodge, to which before I even served as a member of the progressive elected Grand Line, I shared in your concerns. Now as your Grand Master, I believe it is my Masonic and fiduciary responsibility to report to you on our findings.

In reviewing the internal audit of our Grand Lodge records, there was a concern that money from the Grand Lodge was owed to the Masonic Charity Foundation of New Jersey ("MCF"); however, there was no clarity as to the extent of how much the Grand Lodge owes the Foundation until this past week when the final independent audit report was provided. Although the independent audit has confirmed that our past-due pass-throughs to The George Washington Masonic National Memorial, New Jersey DeMolay and New Jersey Rainbow for Girls were fully satisfied, it has been determined that the Grand Lodge has not been current on its pass throughs to the MCF. Specifically, as per the independent audit, as of April 30, 2018, the Grand Lodge owed the MCF the sum of \$393,728.00, which consists of unpaid home fees for initiates in the amount of \$117,505.00 and for home maintenance fees in the amount of \$276,223.00. The pass-throughs are the donations collected through your dues payments which are part of the Grand Lodge assessment. These donations are earmarked for the Masonic Charity Foundation,

Rainbow, DeMolay, HTMT and George Washington Memorial. You pay them through your dues which in turn, your lodge remits to the Grand Lodge yearly with its annual return. For several years, these donations were not fully passed through to Charities. The minutes of the Grand Lodge trustees reflect the elected line and I, when given reports of the deficiencies, demanded that they be fully paid. We can only demand the arrears to be paid which we were made aware of. The reports were conflicting. Originally, we were told we were up to date by the Grand Lodge office as the minutes of the Grand Lodge Trustees reflect. We were informed that Rainbow, DeMolay were paid their delinquent pass-throughs. On 6/27/17 the George Washington National Memorial was paid \$164,261.00 of delinquent pass-throughs. Just recently the HTMT was brought current, I questioned the monies due the Masonic Charity Foundation and was told by the Grand Lodge office they did not know why Grand Lodge IRS filing of the 990 in 2016 showed \$280,709 as owed to the Foundation. My Brothers, the audit by an independent professional auditor shows the Grand Lodge owes \$393,738.00 as of the date of this letter to you! This is from years of partial payments and, lately nonpayment, as of April 2018. The auditor used the actual amounts paid through your lodges' annual returns and compared these annual payments to the payments made/passed through to the Charities by the Grand Lodge office.

My brothers, this is unacceptable and the MCF must be made whole immediately. There is a potential issue with the IRS if we don't. Our 501c10 status is at risk. The Grand Lodge simply does not have sufficient money in its general operating account available to pay the balance due the MCF. Indeed, nor does the Grand Lodge budget committee can anticipate a surplus anywhere close to that size next fiscal year to satisfy the balance due the MCF.

In light of the foregoing, I am calling a Town Hall Meeting for, April 5, 2019 at 7:00 P.M. at the Fellowship Center, located at Masonic Villages at Burlington, NJ. The purpose of this Town Hall is to present to you in greater details the results of the audit, and to discuss options to immediately address this deficit. In order for you to be properly informed as to the finances of the Grand Lodge in preparation for the annual communication on April 17-18 and the potential pieces of legislation that will have to be adopted at that session to address this significant deficit due MCF, it is necessary that the Town Hall occur prior to the annual communication.

Lastly, your progressive elected grand line and I are further considering other protective measures for compliance purposes to ensure that this never occurs again. Those will be discussed at great length soon. I encourage your active involvement in the discussion as we work together to resolve this
