Greetings Brethren,

Perhaps because we have brothers long overdue to receive their Master Mason degree, I find the degree ceremony has been very much on mine mind. Quick! What is the largest single part of the Master Mason degree ceremony? The craftsmen! Perhaps not the most central, crucial or significant element, but certainly the biggest scene. Yet it seems to be largely ignored. I was surprise not to find any reference to the craftsmen in any of my Masonic reference texts. Yet I believe their presence is important to the story and key to the success of our brotherhood.

A large contingent of the craftsmen approach King Solomon. Not just one or two of them or the foreman. Why so many? Only one was necessary to apprise the king of the crime. Prior to their audience with him, the Senior Grand Warden has already reported the situation and King Solomon has already surmised the reason. When the contingent asks admission, without hesitation,

King Solomon readily admits them all into his court and listens. It is well that he does. Later, in sending them to all four comers of his kingdom, it would make the most sense that they would likely return to their home areas where they knew both the people and the geography. The three sent to the west, knew right where the port of escape by sea was and therefore found the ruffians quickly allowing King Solomon swift and complete justice. Had just one craftsman approached the king the story likely would have a different ending.

The lesson I feel is that our strength as an organization comes from the diversity and unity of our brethren together as a team and not from any one of us, no matter the position. As every brother brings something special to our organization, we as an organization find the whole is greater than the sum of the parts. Let us build on that strength to support each other and grow our organization. To reinforce that strength we should all stay close. In this time of social distancing and closed lodges it will take extra effort. Let' not be "out of sight, out of mind"! Let's keep in close contact with our brothers even while the lodge is closed.

As always communication is important. If not already please make sure you are getting both our app notifications and emails. Also please check in with our older (not me!) members periodically to see if they need anything.



Notes from the Senior Warden.

Greetings Brethren,

Since we're all feeling some isolation to varying degrees during this pandemic, I was curious as to what Long Duration Psychology (LDP) might teach us about our present experiences. NASA studied LDP in order to assess the impact of danger, deprivation, isolation, and confinement on Mir astronauts, during long space flights.

Space flights carry risks of systems failures and possible death. The present pandemic carries similar risks of our bodily systems failing, due to the virus and possible death.

Long duration spaceflights must deal with sensory deprivation, such as lack of gravity but astronauts often found this experience interesting and novel. Presently, we feel some sense of sensory deprivation in the form of an absence of our regular physical routines, activities, and sounds but like astronauts, this experience is new and challenging.

Space flight disrupts astronauts' sense of time and their sleep/wake cycles feel arbitrary. Astronauts do not find this to be problematic, however, as "life in space is never monotonous." With the pandemic, we initially feel some disorientation and may lose track of time but as we learn to use time more creatively, we may also find that our present lives are no longer monotonous.

Astronauts did feel the impact of social deprivation (being away from culture and family) for extended periods. For us, the lack of sports and some hobbies, lack of normal work routines, and disruptions in every-day interactions with others have become problematic for us.

What can we learn from the experiences of these astronauts? They intensely focused on projects and experiments of interest and some found comfort in quiet time, during their long space flights. Mir astronauts did exercise and had some recreational activities. Some read books, others watched videos, and some did artwork. They also tried to make their lives as "normal" as possible.

Presently, many of us have been watching movies, reading books, cooking, checking in with friends, and organizing ourselves. Others are meditating and reflecting on their lives and other important things to them. In time, we will adjust to the "new normal" and, when we finally return to our former routines, hopefully, we will become more mindful and appreciative of our lives and of those around us.

EDICT

WHEREAS, the current worldwide COVID-19 pandemic has impacted the everyday lives of all citizens of the State of New Jersey, and the world for that matter; and.

WHEREAS, the President of the United States has deemed it necessary to declare a National Emergency to exist; and

WHEREAS, the Governor of the State of New Jersey has deemed it necessary to issue a series of Executive Orders, which severely curtail the operations of all businesses which have not been designated as "Essential", and restricted the personal movements of the citizens of the State, including the issuing of "stay at home" and social distancing restrictions; and,

WHEREAS, those restrictions have adversely impacted the ability of the Grand Lodge of the Most Ancient and Honorable Society of Free and Accepted Masons for the State of New Jersey (the "Grand Lodge"), and all constituent Masonic Lodges, and all Concordant and Appendant Masonic bodies, to meet in lodge and do Masonic work; and,

WHEREAS, these restrictions are anticipated to exist, and interfere with the Peace and Harmony of this Grand Lodge, for the immediately foreseeable future, and will, necessarily, prevent the ability to convene the presently scheduled Annual Communication of the Grand Lodge, the election and installation of incoming Grand Lodge officers, and adversely impact a number of the By-Laws of this Grand Lodge; and,

WHEREAS, it is my opinion, as the Grand Master of Masons for the State of New Jersey, in conjunction with discussions among the Elected Grand Lodge Officers, that it is essential for the health and well-being of the officers and members of the Craft, as well as the orderly continuation of the necessary business of this Fraternity, that adjustments to the operations of the Grand Lodge during the pandemic restrictions must be made;

NOW THEREFORE, for the good of the Craft, by virtue of the authority in me vested as Grand Master of Masons for the State New Jersey, it is this 23rd day of April, 2020, **EDICTED AND ORDERED** as follows:

- I hereby suspend the operation of any section of the Constitution, By- Laws, rules or regulations of the Grand Lodge, which is not a Landmark, as is necessary to accomplish the aforesaid essential purposes, including, but not limited to, the specific sections delineated below.
- The Annual Communication presently scheduled for April 21-23, 2020, is hereby postponed. All
 presently installed Grand Lodge officers shall continue to hold their present offices until the
 election, or appointment, and installation of their successors.
- 3. Pursuant to Title Three, Article IV, Section 1, Part 2, relating to emergencies based upon federal or other regulations which restrict attendance at the annual communication, or travel thereto, the postponed date for the annual communication shall be November 9-10, 2020. The location of the communication shall Bally's Hotel and Casino, Atlantic City, NJ. All members are hereby noticed

of the same, sufficiently in advance thereof, that all members have due and timely notice. The number of attendees shall be designated by the Grand Master in advance thereof based upon any emergency governmental orders then in effect.

- 4. All business requiring votes of the members, including but not limited to, the election of the Junior Grand Warden and the Grand Lodge Trustees, will be conducted in person or by Internet voting. All Worshipful Masters, Senior and Junior Wardens, shall be automatically registered for electronic ballots by the balloting committee. All Past Master's should register for their electronic ballot, pursuant to the procedure directed at page 7 of the Spring 2020 edition of *The New Jersey Freemason* magazine. Proxies shall not be permitted to vote, since the more senior officers of their lodges shall already be registered for electronic voting.
- 5. Any related organization which regularly conducts voting at the Annual Communication of Grand Lodge (Masonic Charity Foundation and Historic Trenton Masonic Temple, Inc.), is hereby encouraged to take such appropriate actions as are necessary to conform its annual meeting to the November 9-10, 2020 dates, and for its voting requirements to match those of Grand Lodge. As previously agreed upon, Grand Lodge shall administer all voting for these entities.
- 6. The time period for the publication of the proceedings of the Grand Lodge Annual Communication, as set forth in Title Four, Article II, Section 2, Part 2, shall be extended to a date not later than nine (9) months following the conclusion of the Annual Communication.
- The time for withdrawal of nominations under Title IV, Article III, Section 3, Part 1(b) is extended.
 Any nomination for office may be withdrawn in writing, by the nominee, not later than October 30,
 2020.
- 8. The time period for a late nominations due to vacancy, if any, under Title IV, Article III, Section 3, Part 2, is amended to indicate that delayed nominations may be received up until three (3) days prior to the opening of the Annual Communication, in order that the name of the nominee can be distributed electronically for balloting. In the event of a vacancy existing for which no nomination has been made, the Grand Master may receive nominations for such offices from the floor of the Grand Lodge, and any such nominees may be elected by a plurality vote of the members present at the Annual Communication.
- 9. The Grand Lodge Budget and Finance Committee, shall create an interim budget, for the ongoing operations of Grand Lodge for the period from May 1, 2020 through November 10, 2010, consistent with the proposed budget published at page 27 of the Spring 2020 Edition of *The New Jersey Freemason* magazine. The Trustees of the Grand Lodge are hereby authorized to continue to operate the Grand Lodge business in accordance with that interim budget.
- 10. All previously published dates for Receptions, Grand Lodges of Instruction, or other Grand Lodge events, are hereby postponed. A new schedule of dates shall be coordinated among the members of the Elected Grand Line and notice shall be provided in accordance therewith in due and timely fashion.
- 11. Currently the David Brearley Award requires newly raised brothers to achieve the six required activities, and at least four of the elective activities within one year from the date upon which the

Brother was raised to the Sublime Degree of Master Mason. The required activities all invo regular meetings of Lodges, or the District, and Lodge social or charitable events. The elective activities, similarly, involve participation in Lodge, Grand Lodge, Rainbow or DeMolay activities. In as much as all of those activities are presently suspended during the Covid—19 emergency, the ability of those newly raised brothers to fulfill the requirements within the one year time limit has necessarily been prevented. Accordingly, in order to afford those brothers the ability to recoup the lost opportunities, the time in which to complete the requirements for the David Brearley Award is hereby extended through the November 10, 2020 date for the conclusion of this year's Grand Lodge Annual Communication.

12. The edict of March 13, 2020, as extended by the supplement of March 20, 2020, suspending all meetings events etc. until April 30, 2020 is hereby further extended, and all Masonic meetings and events shall remain suspended until May 15, 2020, consistent with the emergency orders of the office of the Governor, or until further order of the Grand Master, Lodges and Districts have been successfully continuing to hold informal communications with each other, via the ZOOM platform, and/or similar platforms. All Lodges and other Masonic organizations within this State are encouraged to participate in such informal sessions and gatherings. Lodges are hereby authorized to transact extraordinary and essential Lodge business through the ZOOM platform provided, however, that a request for dispensation must first be made to the District Deputy Grand Master, who shall, thereafter, pass the request up the chain of command to the Grand Secretary, who, in turn, shall pass the request to the Grand Master. The Grand Master alone shall determine whether or not to grant that dispensation. If the dispensation is granted, the Lodge holding such a meeting under dispensation shall provide due notice to the members, and the meeting must include the mandatory officers for the opening of the Lodge. Minutes shall be taken and recorded by the Secretary, or an ad hoc Secretary, which minutes shall ultimately be presented for approval of the Lodge and recorded in the Lodge minutes histories. If the extraordinary meeting requires a vote to be taken, the vote may be taken with the usual voting sign of a Mason, providing all participants can be seen on video. If they cannot, the votes shall be taken by a roll call vote of all present in the meeting. No voting which would normally require a secret ballot shall be permitted. Appendant and Concordant bodies, if permitted by their governing bodies and as consistent with rules and regulations than may have been issued by said governing bodies, may hold business meetings virtually.
